'300 Phone Lines Allotted To Ex-Min Extended To Sun TV'

New Delhi: In more trouble for former telecom minister Dayanidhi Maran, the Central Bureau of Investigation (CBI) has registered an FIR against him and BSNL officials for alleged allotment of over 300 high-speed telephone lines to Maran's residence in Chennai which were extended to his brother's TV channel.

CBI sources said that the FIR was filed after its preliminary enquiry (PE) found enough material to proceed with a case against Maran and two BSNL officials - the then chief general manager Bramhanathan and MP Veluswami.

The fresh case comes as the CBI is wrapping up its probe into the Aircel-Maxis deal case, in which Maran is an accused. Sources said Maran would be called for questioning soon in the fresh case. CBI officials said the PE was registered in 2011, and it was wrapped up in July.

Sources said 323 tele phone lines allegedly in the name of the BSNL general manager connected Maran's Boat House residence with the Sun TV office through a dedicated underground cable during his tenure as telecomminister.

The probe had started in 2011, nearly four years after getting complaints that a 'virtual' telephone exchange was allegedly set up at Maran's home to allow data transfer from Sun TV.


Dad kills baby for refusing to take medicine
